10. Ulwazi lokuthi ungasenza kanjani isicelo se-PAIA kithi ⁷

- 10.1. Uma ungathanda ukwenza isicelo se-PAIA ku-MSF-SA, kufanele wenze kanjalo kwiFomu 2 lesiThasiselo A seSaziso Sikahulumeni No. R 757 samhla zingama-27 kuNcwaba 2021, noma ifomu elifanayo kakhulu. Ukuze kube lula kuwe, sifake ifomu kule Manuwali. Lifakwe njengeSithasiselo 2.
- 10.2. Kubalulekile ukuthi ubhekise noma yiziphi izicelo zokufinyelela kumarekhodi kuSikhulu Sezolwazi se-MSF-SA ekhelini, inombolo yefeksi noma ikheli le-imeyili elinikezwe ngenhla kule Manuwali.
- 10.3. Kubalulekile ukuthi usinikeze imininingwane eyanele efomini lesicelo ukuze sikwazi ukukuhlonza kanye nerekhodi olidingayo kithi. Kufanele futhi usazise ukuthi iyiphi indlela ongathanda ukufinyelela ngayo kumarekhodi, isibonelo amakhophi aphrintiwenoma ifomethi ye-elektronikhi. Sicela usazise ukuthi, ngaphezu kwempendulo ebhaliwe, ungathanda yini ukuthi sikuthinte ngenye indlela, isibonelo ngocingo noma nge-imeyili. Uma kunjalo, sicela usinikeze imininingwane yakho yokuxhumana eyengeziwe.
- 10.4. Kubalulekile ukuthi uhlonze ilungelo ofuna ukulisebenzia noma ukulivikela futhi usinikeze incazelo yokuthi kungani irekhodi eliceliwe lidingeka ukuze kusetshenziswe noma kuvikelwe lelo lungelo.
- 10.5. Uma wenzela omunye umuntu isicelo, kufanele ulethe ubufakazi besikhundla osenza ngaso isicelo. Lobu bufakazi buyoba ngaphansi kokwaneliseka kweSikhulu Sezolwazi se-MSF-SA.

- 10.6. Uma ungalisebenzisi ifomu elijwayelekile (eliyisithasiselo sesi-2 esinamathiselwe kule Manuwali), isicelo sakho singanqatshwa ngenxa yokuntula ukuthobela izinqubo, sinqatshwe (uma ulwazi olwanele lunganikezwanga noma ngenye indlela) noma sibambezeleke.
- 10.7. Sicela wazi ukuthi kuzodingeka futhi ukuthi ukhokhe izimali ezinqunyiwe. Uhlu Iwezimali ezikhokhwayo ezinqunyiwe maqondana nezicelo, kanye maqondana nokufinyelela kumarekhodi (uma isicelo samukelwe) lubalulwe kuSithasiselo sesi-3 sale Manuwali.
- 10.8. Uma udinga usizo lokugcwalisa ifomu lesicelo, i-MSF-SA izokusiza mahhala.
- 10.9. Uma ucela amarekhodi angahlobene nesicelo sakho, sizokwazisa kuqala ngemali enqunyiwe (uma ikhona) ngaphambi kokucubungula isicelo futhi. Ungafaka isikhala sangaphakathi noma isicelo eNkantolo, ngokumelene nemfuneko yethu yokuthi ukhokhe imali yesicelo.
- 10.10. Sizobe sesithatha isinqumo ngesicelo futhi sikwazise ngefomu elibekwe kuSithasiselo sesi-4.
- 10.11. Uma isicelo sakho samukelwe, kufanele kukhokhwe enye imali yokufinyelela ukuze kukhiqizwe kabusha, kuseshwe futhi kulungiswe irekhodi, nanoma yisiphi isikhathi eseqe amahora anqunyiwe okucinga nokulungisa irekhodi ukuze lidalulwe..
- 10.12. Uma ukucinga noma ukulungiswa kwerekhodi, ngokubona kweSikhulu Esibhekelle Ulwazi, kuzodinga amahora angaphezu kwayisi-6, sizodinga ukuthi ukhokhe njengediphozithi, ingxenye yemali yokufinyelela. Sizokwazisa ngefomu elihambisana nefomu elikuSithasiselo sesi-4.
- 10.13. Sicela wazi ukuthi zonke izicelo esizitholayo, zizocutshungulwa futhi zicutshungulwe ngokuhambisana ne-PAIA. Kubalulekile ukukhumbula ukuthi, nakuba silishicilele le Manuwali futhi sachaza izigaba nesihloko solwazi noma amarekhodi esiwaphethe, lokhu akukuniki noma yimaphi amalungelo okufinyelela lolo Iwazi noma amarekhodi, ngaphandle kwemibandela ye-PAIA. Amarekhodi ongeke ube nelungelo lokuwafaka lawo ezinkampani zangaphandle ezingabantu bemvelo (okungukuthi abantu), ulwazi Iwezohwebo Iwezinkampani zangaphandle, ukuphepha kwabantu noma ukuvikelwa kwempahla, lawo anikwe ilungelo lokukhiqizwa ezinkantolo zomthetho, ezohwebo, ulwazi Iwebandla elizimele kanye nolwazi locwaningo lomuntu wesithathu kanye nebandla elizimele.

11. Ulwazi oluhlobene ne-POPIA⁸

11.1. Isingeniso

11.1.1. I-POPIA idinga ukuthi sikunikeze ulwazi oluthile oluhambelana nendlela yowlazi lomuntu siqu esilucubungulayo, phakathi kokunye, olusetshenziswa ngayo, oludalulwayo futhi olucekelwa phansi. Sibeke imininingwane edingekayo ngezansi.

11.2. Izicelo zolwazi ezenziwe ngaphansi kwe-POPIA

- 11.2.1. I-POPIA ihlinzeka ngokuthi, ngemva kobufakazi bokuthi ungubani, ungase usicele ukuthi siqinisekise, mahhala, ukuthi sinalo yini ulwazi lomuntu siqu ngawe noma cha. Ungase futhi ucele irekhodi noma incazelo yowlazi lomuntu siqu olumayelana nawe, okuhlanganisa ulwazi mayelana nobunikazi bezinkampani zangaphandle ezikwazile ukufinyelela noma eziye zafinyelela kulwazi olunjalo.
- 11.2.2. Izicelo zolwazi lomuntu siqu ngaphansi kwe-POPIA kufanele zenziwe ngokuhambisana nezinhlinzeko ze-PAIA.⁹ Lolu hlelo luvezwe endimeni ye-10 ngenhla.
- 11.2.1. Uma sikuhlinzeka ngolwazi lomuntu siqu Iwakho, unelungelo lokucela ukulungiswa, ukususwa noma ukucekelwa phansi kolwazi Iwakho siqu, ngefomu elinqunyiwe. Uma ufisa ukucela ukulungiswa, ukususwa noma ukucekelwa phansi kolwazi lomuntu siqu, kufanele ulethe isicelo kwisikhulu solwazi ekhelini leposi noma lendawo, inombolo yefeksi noma ikheli le-imeyili elibekwe ngenhla efomini elifakwe lapha njengeSithasiselo 5.
- 11.2.2. Ngaphansi kwezimo ezithile, ungase futhi uphikise ukucutshungulwa ngolwazi lomuntu siqu Iwakho efomini elinqunyiwe. Ukuze kube lula kuwe, sifake ifomu kule Manuwali. Lifakwe njengeSithasiselo 6.⁹
- 11.2.3. Sizokunikeza isilinganiso esibhaliwe semali yokukuhlinzeka ngolwazi lomuntu siqu Iwakho, ngaphambi kokukunikeza ngamasevisi. Singase futhi sidinge ukuthi usinikeze idiphozi yakho yonke noma ingxenye yemali ngaphambi kokukunikeza imininingwane yomuntu siqu eceliwe.¹⁰

- 11.4. Uma ufisa ukuphikisa i-MSF-SA, noma abahlinzeki besevisi begembu lesithathu le-MSF-SA, ukucubungula ulwazi lomuntu siqu lwakho, sicela ugcwalise Isithasiselo 6.
